These fees may be paid in total or customers may pay a deposit of **\$100.00** which includes an additional Lien Recording Fee of \$40.00 with the balance financed by GSWSA at 12% interest per year for a period of up to 20 years. Once service is made available, the monthly installments on the financed fees will be added to each billing.

After a project receives service authorization, a Water Tap Fee of \$565.00 will be due in lieu of the Water Meter Base Setting Fee.

Grand Strand Water and Sewer Authority rates and charges are subject to periodic adjustments. Therefore, the fees due will be based on the approved rate schedule in place at the time a service application is completed.

The enclosed fees are effective as of July 1, 2009.

PART # 2:

BASE AND USAGE CHARGE FOR WATER SERVICE:

After the project has received service authorization, each customer will receive a monthly billing for base and volume charges. Listed below are the monthly charges for a typical customer.

Once service is made available, the monthly installments on the financed fees will be added to each billing.
- Grand Strand Water and Sewer Authority rates and charges are subject to periodic adjustments. Therefore, the fees due will be based on the approved rate schedule in place at the time a service application is completed.
- After a project receives service authorization, there is an additional Sewer Tap Fee of \$750.
- The Pumping Unit Installation Fee includes the installation of the electrical service and up to 150 L/F of service line. Each L/F of service line above 150 will be charged an additional \$5 per L/F.
- The enclosed fees are effective as of July 1, 2009.
- ***New Account Fee will not be due if customer has an existing water only account with GSWSA.**

PART 2: BASE AND USAGE CHARGE FOR SEWER SERVICE:

Once service is made available, each customer will receive a monthly billing for base and volume charges. Listed below are the monthly charges for a typical customer.
