








Chief Executive Officer

Grand Strand Water and Sewer Authority (GSWSA) experienced healthy growth during 2015 as a result of a more robust local economy with growth in tourism, commercial real estate and residential housing. An increase in new developments added \$7.6 million in water and sewer utility assets. 2,884 new customers were added, an increase of 28 percent over the previous year. At year end, GSWSA served over 83,000 customers in Horry, Georgetown, Marion and Dillion Counties in SC and Columbus County, NC.

GSWSA treated and distributed over 14.7 billion gallons of water and collected and treated over 10.9 billion gallons of wastewater for the year – a net increase of 1.0 percent over 2014.

Major capital improvements in the 2015 fiscal year included completing a \$4.7 million 30" waterline from Highway 501 to International Drive. This line significantly increases the water capacity available to Carolina Forest, North Myrtle Beach and Little River. GSWSA also completed construction of a \$20 million wastewater treatment plant located in Bucksport. The plant provides 5 million gallons per day of wastewater capacity — enough to serve an additional 20,000 new homes. Additionally, GSWSA invested \$4.2 million to extend water and sewer lines into rural communities. Finally, \$11.4 million was spent to extend the life of our existing facilities through upgrades, repairs and maintenance projects.






















Financial Summary


Total Assets and Liabilities

Total Operating Revenue


Operating revenue was up \$4.8 million over last year, an increase of 6.5%.






Total Revenue

Total revenue was up by \$14.6 million over FY 2014.




Total Assets

Typical Residential Bill

GSWSA rates are among the lowest in the region. The typical residential monthly water and sewer bill based on an average of 8,000 gallons in 2000 was \$34.19. For FY 2015, the same typical monthly bill was \$44.76, an increase of less than 2% per year.
