Upon motion duly made by Mr. Lazarus, seconded by Mr. Hardee, the Board voted to opt out of the class action settlements in Aqueous Film-Forming Foam Products Liability Litigation, MDL No. 2:18-mn-02873-RMG, Settlement Agreements between Public Water Systems and 3M Company and EIDP, Inc. and related entities ("Class Action Settlements").

Upon motion duly made by Mr. James, seconded by Mr. Singleton, the Board voted to engage John B. White & Associates, Cory Watson, Whetstone, Perkins, & Fulda, The Rankin Law Firm, and the Brittain Law Firm to assist with opting out of the Class Action Settlements and pursuing a lawsuit against defendants responsible for PFOS and PFOA in drinking water in exchange for a 30% contingency fee, conditioned upon outside counsel's fees being reimbursed from the 30% contingency fee.
